 TAKE NOTICE that the Pensions Regulator of Napier House, Trafalgar Place, Brighton BN1 4DW has reviewed the orders made subsequent to a determination on 9 July 2008.

3. Determination

A hearing of a Compulsory Review (pursuant to Section 99 of the Act) took place on 28 October 2008 of the determination made under the Special Procedure by the Determinations Panel on 9 July 2008 when the panel determined that orders be issued as detailed below.

4. Decisions on Compulsory Review

Having considered the written representations received from the directly affected parties and the Regulator the Determinations Panel has determined as follows in respect of the orders detailed in '3 Determination'.

Suspension of Trustees under Section 4 of the Pensions Act 1995

The Pensions Regulator hereby determines that, pursuant to section 99(3) of the Pensions Act 2004 the Orders made on 9 July 2008 be substituted as follows:

1. GP Noble Trustees Limited

The Pensions Regulator hereby suspends GP Noble Trustees Limited under section 4(1)(a) of the Pensions Act 1995, pending consideration being given to the making of a prohibition order against G P Noble Trustees Limited under section 3(1) of the Pensions Act 1995, of trust schemes in general pursuant to section 4(3) of the Pensions Act 1995 with effect on and from 9 July 2008 until 31 January 2009 or until a Determination Notice is issued by the Determinations Panel in respect of any prohibition proceedings taken against G P Noble Trustees Limited.

This order has the effect of prohibiting GP Noble Trustees Limited, during the period of suspension, from exercising any functions as a trustee of trust schemes in general.

2. BDC Trustees Limited

The Pensions Regulator hereby suspends BDC Trustees Limited under section 4(1)(a) of the Pensions Act 1995, pending consideration being given to the making of a prohibition order against BDC Trustees Limited under section 3(1) of the Pensions Act 1995, of trust schemes in general pursuant to section 4(3) of the Pensions Act 1995 with effect on and from 9 July 2008 until 31 January 2009 or until a Determination Notice is issued by the Determinations Panel in respect of any prohibition proceedings taken against BDC Trustees Limited.

This order has the effect of prohibiting BDC Trustees Limited, during the period of suspension, from exercising any functions as a trustee of trust schemes in general.

3. Mentor Pension Trustees Limited

The Pensions Regulator hereby suspends Mentor Pension Trustees Limited under section 4(1)(a) of the Pensions Act 1995, pending consideration being given to the making of a prohibition order against Mentor Pension Trustees Limited under section 3(1) of the Pensions Act 1995, of trust schemes in general pursuant to section 4(3) of the Pensions Act 1995 with effect on and from 9 July 2008 until 31 January 2009 or until a Determination Notice is issued by the Determinations Panel in respect of any prohibition proceedings taken against Mentor Pension Trustees Limited.

This order has the effect of prohibiting Mentor Pension Trustees Limited, during the period of suspension, from exercising any functions as a trustee of trust schemes in general.

4. Gary Alan Cordell

The Pensions Regulator hereby suspends Gary Alan Cordell under section 4(1)(a) of the Pensions Act 1995, pending consideration being given to the making of a prohibition order against Gary Alan Cordell under section 3(1) of the Pensions Act 1995, of trust schemes in general pursuant to section 4(3) of the Pensions Act 1995 with effect on and from 9 July 2008 until 31 January 2009 or until a Determination Notice is issued by the Determinations Panel in respect of any prohibition proceedings taken against Gary Alan Cordell.

This order has the effect of prohibiting Gary Alan Cordell, during the period of suspension, from exercising any functions as a trustee of trust schemes in general.

5. Graham John Pitcher

- 2. This order is made because the Regulator is satisfied that it is necessary to do so in order to secure the proper use or application of the assets of the Schemes pursuant to Section 7(3) (c) of the Pensions Act 1995.
- 3. The powers and duties exercisable by Lyons Davidson Trustee Company Limited shall be to the exclusion of all other trustees of the Schemes pursuant to section 8(4)(b) of the Pensions Act 1995.
- 4. Lyons Davidson Trustee Company Limited's fees and expenses shall be wholly paid out of the Schemes' resources pursuant to section 8(1)(b) of the Pensions Act 1995 as amended by Section 35 of the Pensions Act 2004.

5. Reasons

In carrying out its review of the Determination of 9 July 2008 the Panel considered its powers under Section 99(3)(d) of the Pensions Act 2004 to deal with the matters arising on the review as if they had arisen on the original determination.

Suspension of trustees

The Panel took account of the following matters:

- i. Funds of the schemes that were substantially invested in gilts under a passive investment strategy were transferred into offshore investments without proper regard to the duties of the trustees. Analysis showed that approximately £30m had been transferred into Fareston Ltd, a company incorporated in Nevis, and approximately £22m into an offshore bond MFF. In some cases almost the entire assets of a scheme had been disinvested and transferred into these alternative investments.
- ii. Mr Graham Pitcher, the former Managing Director of GP Noble Trustees, in seeking higher yielding investments was of the view that the members of the schemes were no worse off as a result of the reinvestment strategy he chose to adopt, reasoning that there was always the protection of the PPF and FAS.

- iii. The reinvestments involved a complex structure of advisers, investment managers and custodians spread across a number of countries, including Australia, Gibraltar, Hong Kong, Nevis, Switzerland and Thailand. This had a serious effect on the liquidity of the schemes and the potential for 100% recovery of the schemes' funds. Substantial fees had been paid or were payable to these intermediaries, which were outside customary arrangements for pension scheme investments. Fees charged by Fareston Ltd included an upfront charge of 2% of the £30m assets under management.
- iv. The investment report presented to Fareston Ltd of 31 December 2007 showed that £800,000 had been invested in land in Koh Samui Thailand, £3m in a private company offering term loans @31% p.a. and £1m in a private security company. Subsequently it appears that a further £5.2m was invested in land in Thailand and a further £4.3m in the private security company. The liquidity of these investments and risk involved can be contrasted with previous holdings in gilts.
- v. In his witness statement, dated 7th August, Mr Chris Martin of the Independent Trustee, ITS, reported that the substantial investments in the MUFF bonds cannot be surrendered early by the trustee, do not have any capital guarantees, do not provide any guaranteed returns and have little or no correlation to the factors which affect the liabilities of the nine schemes which were the sources of the investments.
- vi. In making these reinvestments, the trustees had failed to take proper legal advice on the structure and terms of the investments and to take appropriate investment advice or to consult the scheme actuary.
- vii. For the relevant schemes being considered under FAS, the published advice in the FAS Trustee Update No.9 of 6th March 2008 was that trustees were expected to protect the remaining assets in qualifying schemes from unnecessary use or expenditure. Assets were expected to be closely aligned with scheme liabilities and investments managed in a prudent manner.
- viii. In its representations of 11th August 2008, FAS has reported that at no time did GP Noble seek advice from the FAS Operational Unit regarding the change of investments, despite requests in regular trustee updates to do so. Any high-risk investments not only threatened the cost to the Government of providing FAS assistance but could also affect the payments certain members actually received.
- ix. For the relevant schemes undergoing a PPF assessment period, the trustees were under a duty to provide the PPF with information on any significant changes in the investment of the schemes' assets or in the level of expenditure incurred by the schemes. The PPF has reported that it was unaware of any attempt by the trustees to comply with this obligation.

x. In its document titled "Prohibition of trustees", the Pensions Regulator has published advice that professional trustees who charge for their services as trustees or who hold themselves out to be expert in trustee matters are expected to show a higher standard of expertise than lay trustees. Should such a trustee, or firm of trustees, consistently fall short of the standards that the Regulator could reasonably expect from pension professionals, they could be considered for prohibition.

Appointment of independent trustee

In light of the matters set out above, the Panel is satisfied that it is necessary to appoint an independent trustee with exclusive powers to enable the assets of the schemes to be properly secured and applied.

6. Referral to the Pensions Regulator Tribunal

You have the right to refer the matter to which this Final Notice relates to the Pensions Regulator Tribunal ("the Tribunal"). Under section 103(1)(b) of the Act you have 28 days from the date this Final Notice is sent to you to refer the matter to the Tribunal or such other period as specified in the Tribunal rules or as the Tribunal may allow. A reference to the Tribunal is made by way of a written notice signed by you and filed with a copy of this Final Notice. The detailed procedures for making a reference to the Tribunal are contained in section 103 of the Act and the Tribunal Rules.
